POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 5 JUNE 2026

POLL RESULTS OF THE ANNUAL GENERAL MEETING

At the annual general meeting (the “**AGM**”) of Ronshine China Holdings Limited (the “**Company**”) held on 5 June 2026, all the proposed resolutions as set out in the notice of the AGM dated 30 April 2026 (the “**Notice**”) were taken by way of poll.

As at the date of the AGM, the total number of issued shares of the Company (the “**Shares**”) was 1,683,431,417 Shares, which was the total number of Shares entitling the holders (the “**Shareholders**”) to attend and vote for or against the resolutions proposed at the AGM. The Company did not hold any treasury shares (including any treasury shares held or deposited with the Central Clearing and Settlement System established and operated by Hong Kong Securities Clearing Company Limited) or repurchased Shares pending cancellation. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No Shareholder was required under the Listing Rules to abstain from voting on any of the resolutions proposed at the AGM. No person has indicated in the circular of the Company dated 30 April 2026 that it/he/she intends to vote against or abstain from voting on any of the resolutions proposed at the AGM.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. All the resolutions proposed at the AGM were approved by the Shareholders. The poll results in respect of the respective resolutions proposed at the AGM were as follow:
