UNAUDITED OPERATING STATISTICS FOR AUGUST 2021

The board (the “**Board**”) of directors (the “**Directors**”) of Ronshine China Holdings Limited (the “**Company**”, together with its subsidiaries, associates and joint ventures, the “**Group**”) is pleased to announce that during the month ended August 2021, (i) the total contracted sales of the Group amounted to approximately RMB11,022,938,653; (ii) the contracted gross floor area of the Group amounted to approximately 557,974 square meters; and (iii) the average contracted selling price of the Group amounted to approximately RMB19,755 per square meter.

For the eight months ended 31 August 2021, (i) the aggregate contracted sales of the Group amounted to approximately RMB109,842,347,268; (ii) the aggregate contracted gross floor area of the Group amounted to approximately 5,356,396 square meters; and (iii) the average contracted selling price of the Group amounted to approximately RMB20,507 per square meter.

The above-mentioned operating statistics are unaudited and are based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collecting such information.
